# **Biographical / Historical Note**

The Equal Rights to All Association (ERA) was founded on May 19, 1896 and was originally called the Southern States Woman Suffrage Conference. The organization praised reforms for issues such as child labor and juvenile courts, and supported civic improvement in addition to their focus on woman suffrage.
