## **Call to Order**

Anne Redd called the meeting to order at 12:35 pm

# Motion to Adopt the Agenda

Aleta Leckelt made a motion to adopt the agenda. Fairleigh Jackson seconded the motion. The motion was **unanimously approved**.

# **Motion to Adopt the Minutes**

Lee Felterman made a motion to adopt the minutes from Board of Directors of the Louisiana State Museum meeting held November 26, 2018. Mary Coulon seconded the motion. The motion was unanimously approved.

#### **Interim Director's Report**

Steven Maklansky discussed the newly opened exhibitions (Land and Sea (PhotoNOLA); CISLANDERUS; Mapping the Crescent; Pontalba). He also discussed the deaccessioning project and the upcoming exhibition at Capitol Park Museum which includes the hearse which carried Martin Luther King Jr.'s

body. Also announced was the exhibition upcoming at LSHOF, <u>Pelican State Goes to War</u> (a World War II travelling exhibition). He provided an update on new education programs and discussed the Museum Governance RFP which is soon to be released.

#### Collections

The Collections report was presented by Fairleigh Jackson.

- 1. Approval of incoming loans for exhibitions (Attachment A) Suzie Terrell made a motion to approve all incoming loans. The motion was **unanimously approved**.

Will Wilton provided an Irby/Finance update in regards to a recent rental of an apartment. Rosemary Ewing made a motion to accept Ben Jacobson as the new tenant for 503 St. Ann, 2<sup>nd</sup> floor, Lee seconded the motion and it was **unanimously approved**.

## **Report from Louisiana Museum Foundation**

Susan Maclay presented the report for LMF, which included the results of the internal audit conducted by DCRT. She also provided an update on programming associated with the Pontalba exhibition. Plans for a Jacques Amans exhibition are in the works.

#### **New Business**

Lee Felterman discussed the Patterson roadway project. The gate at the front of the museum is typically closed. A DOTD project has been funded for FY 2020-21. Aleta Leckelt moved for a memorandum be drafted from the LSM Board to DOTD, in support of expediting the roadway project. Suzie Terrell seconded the motion and it was **unanimously approved**.

# II. Proposed Deaccessions

## **Accession Number 08266.01-.06**

Objects: Six (6) woven wool serapes/ponchos, Unknown maker(s), Oaxaca, Mexico, early

twentieth century.

**Acquisition Date:** October 1922 **Donor:** Mr. Willard H. Case.

**Documentation/Provenance:** Any documentation regarding the donor's acquisition of these textiles is unknown. The donor began making gifts of artifacts to LSM in 1922 and continued doing so until 1948. His gifts cross nearly all departments at the Museum. It can be assumed that the donor acquired these textiles as souvenirs during a trip to Mexico, but there is no proof of this. The original gift included eleven textiles, but only six remain documented in the LSM collection. According to the accession log, the Museum seems to have acquired these textiles from the donor by exchange for a painting, and the textiles were technically placed on loan. The loan was officially resolved during the 2007-2008 Loan Resolution Project, which simply affirmed the original documentation of the acquisition of the textiles by LSM in exchange for an unknown painting. Catalogue worksheets from 1973 in the master files for these textiles indicate that they were displayed at the time in the Presbytère in an exhibit on the Mexican War.

**Deaccession Justification Narrative:** Because these textiles originated in Mexico, they bear no relevance to Louisiana's history or culture. They seem to be the type of textiles that could be acquired as souvenirs by travelers to Mexico, although it seems unlikely that they would have been worn by the donor back home due to their ethnic quality. In the early years of the Museum's existence, artifacts of all types were acquired by the Museum whether or not they bore any connection to Louisiana history. This was likely due in part to the effort of Museum staff to grow the collection by accepting artifact donations of all kinds, especially from regular donors like Mr. Case, who gifted over 100 various artifacts over the course of 26 years. At this point, there is no logical or foreseeable exhibition in which these textiles could be featured.

Object: Mardi Gras souvenir, crawfish on crown with umbrella

**Acquisition Date:** 2000 **Donor:** Ms. Adrienne Berney

**Documentation/Provenance:** The donor purchased this object in 1999 at an antique store called Discount City, previously located at 1019 Decatur Street and now defunct. She paid \$1.00 for it. She purchased it explicitly for donation to LSM. At the time, Berney was LSM Curator of Decorative Arts.

**Deaccession Justification Narrative:** This homemade folk art souvenir by an unknown maker offers nothing to the study of carnival history. It is a glued-together trifle that combines unrelated

objects in an attempt to create a humorous scene using a genuine crawfish shell. It is generally unadvisable to introduce animal products into the collection for fear of pest infestation. The donor herself, on her original acquisition justification, remarked that the crawfish body may deteriorate significantly over time. The object has the appearance of an amateur craft project, and as such, has no place in a sophisticated museum collection.
